



Office Financial Policy

Thank you for choosing Vega Plastic Surgery for your plastic or reconstructive services. We appreciate you entrusting your care to us. The following is a summary of our Financial Policy.

Insurance

We currently participate with the following Insurances: Excellus BCBS, MVP, Medicare, POMCO, Cigna (PPO) AND RMSCO (Lifetime Benefit Solutions). All other insurances will be considered Out-of-Network, and patients may be subject to higher out of pocket expenses. It is your (the patient) responsibility to contact your insurance company, prior to your appointment, regarding network participation. We will submit claims on your behalf. Should you have any questions or concerns, our Billing Specialist is on hand to assist you.

Payment

All copays, coinsurance and/or deductibles are required to be paid at the time of service. We accept the following forms of payment: Cash, Checks (with a valid ID; no out of state), Visa, Master Card, Discover, American Express. Financing through CareCredit® is also available. Please ask for details.

Our office charges a \$20 fee for completing disability paperwork. There is a returned check charge of \$30.

Missed Appointments/Late Cancellations

We understand that sometimes situations may arise where you cannot keep your scheduled appointment; in these cases we ask that you notify us as soon as possible. If you cancel with less than 24 hours' notice or NO SHOW for your appointment, a \$50 fee will be charged.

For IN OFFICE PROCEDURES, including TATTOOS, 72 hour notice is required or a \$75 fee will be charged.

Cosmetic Consultation

A charge of \$50 is required for a cosmetic consultation. To reserve your consultation, a NON REFUNDABLE \$25 charge is taken when the appointment is made and the remaining \$25 is charged on the day of your appointment. If you should cancel your appointment with less than 24 hours' notice or NO SHOW for the appointment, you will be charged the full \$50.
